

1. A person shall be deemed **Scheduled I public Service if he or she falls under the following portfolio and shall make their declarations to the Commission:**

- (a) The prime Minister and ministers;
- (b) The Speaker and Members of the national Assembly;
- (c) The Chairperson and Members of the National Council;
- (d) The holders and Members of the Constitutional offices;
- (e) The **Secretary to Government** including Cabinet Secretary;
- (f) The head of Armed Forces;
- (g) The Chief of police;
- (h) The Ambassadors and Consuls;
- (i) The Heads of Autonomous Agencies;
- (j) The Dzongdags and Drangpons;
- (k) The Chairpersons and/or Chief Executives of Corporations including financial institutes;
- (l) The Heads of registered civil Society Organizations;
- (m) The Heads of registered Religious organizations;
- (n) The Chairpersons of DzongkhagTshogdu's; and
- (o) The Chairpersons of ThromdeTshogdes.

II. A person shall be deemed **Schedule II public Servant if he or she falls**

under the following Category and shall make his or her declaration to his or her agency:

- (a) **All public Servants**, excepting teachers, of **position level P5 and above** in civil **Service Agencies**, constitutional offices and Autonomous Agencies;
- (b) All Gups,
- (c) **All Public Servants who are not covered under section (8)(a) and (b) but falling under the following occupational group in any position level:**
 - (i) Architectural and engineering Service group;
 - (ii) Finance and Audit Services Group;

- (iii) Custom and immigration Service Group;
- (iv) Forest and Environment protection Group;
- (v) Property and Procurement management group;
- (vi) Human Resources Development Group;
- (vii) Store in-charges and mess in-charge from general Administration Services group;
- (viii) Legal, Judiciary and legislative Services group;
- (ix) Trade, Industry and tourism Services Group;
- (x) Transportation and Aviation Services Group;
- (xi) Religious Organization (Five lopens, Drungchen)
- (xii) Armed forces (Drimpon and Above);and
- (xiii) Royal Bhutan police (Drimpon and Above)

(d) All Public Servants specialist in brackets of following organizations:

- (i) Corporations (Managers, Administration officer, HR personal, Finance personal, Procurement personal, Engineering personal Legal personal, Auditor, Cashers and other officers);
- (ii) Financial institutions (Manager , HR personal , finance personal, Credit and Loan personal, Procurement personal, Engineering personal, Legal personal Auditors, Cashers, font Desk officers, under writer, Inspectors, and other officers);
- (iii) Civil Society organization (Managers, HR personal, Finance personal, Procurement personal, Engineering personal Legal personal, Auditor, Cashers and other officers);
